I hereby release, discharge and covenant not to sue YWCA Yonkers, its administrators, directors, agents, officers, members, volunteers, employees, and other participants (“releasees”) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise, and I further agree that if, despite this release and waiver of liability, assumption of risk and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any litigation expenses, attorneys’ fees, loss, liability, damage, or cost which any may incur as a result of such claim.
